## **ORDINANCES AND OTHER RESOLUTIONS**

Ordinance 700 AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF STANHOPE, IOWA. The City Code of Stanhope, Iowa, propose amending by repealing all previous ordinances pertaining to "Electric Utility Rates", and is adopted in lieu thereof:

FY26 3% increase a month for the first-year electric rates and FY27 a 2% increase a month for the next 4 years for a total of five years on increase. Roll called, all voting NAY.

FY26 5% increase a month for the first-year electric rates and FY27 a 2% increase a month for the next 4 years for a total of five years of increase. Motion to approve the electric rate increase made by Jensen, seconded by Haman. All voting yes, motion carried.
